1. Privacy Policy

AALCALDE MUSIC informs users of the website about its policy regarding the treatment and protection of personal data of users and customers that may be collected by browsing or contracting services through its website. In this sense, **AALCALDE MUSIC** guarantees compliance with the current legislation on the protection of personal data, reflected in Organic Law 15/1999 of 13 December, on the Protection of Personal Data and Royal Decree 1720/2007, Of 21 December, which approves the Development Regulation of the LOPD. Use of this site implies acceptance of this privacy policy.

2. Collection, purpose and processing of data

AALCALDE MUSIC has the duty to inform the users of its website about the collection of personal data that can be carried out, either by sending e-mail or by completing the forms included in the website. In this sense, **AALCALDE MUSIC** will be considered as responsible for the data collected by means described above. At the same time **AALCALDE MUSIC** informs users that the purpose of the processing of the collected data includes: Attention of requests made by users, inclusion in the agenda of contacts, provision of services and management of business relationship. The operations, management and technical procedures that are carried out in an automated or non-automated manner and that enable the collection, storage, modification, transfer and other actions on personal data, are considered as processing of personal data. All personal data, which are collected through the **AALCALDE MUSIC** website, and therefore has the status of processing of personal data, will be incorporated into the files declared before the Taiwanese Agency for Data Protection by **AALCALDE MUSIC**.

3. Communication of information to third parties

AALCALDE MUSIC informs users that their personal data will not be transferred to third organizations, except that such transfer of data is covered by a legal obligation or when the provision of a service implies the need for a contractual relationship with a processing clerk. In the latter case, only the transfer of data to the third party will take place when **AALCALDE MUSIC** has the express consent of the user.

4. Rights of users

Organic Law 15/1999, of December 13, on the Protection of Personal Data, gives the interested parties the possibility of exercising a series of rights related to the processing of their personal data. As long as the user's data is processed by **AALCALDE MUSIC**. Users may exercise their rights of access, rectification, cancellation and opposition in accordance with the provisions of current legislation on the protection of personal data. To make use of the exercise of these rights, the user must address by written communication, providing documentation proving his identity (ARC or passport), to the following address: ANTÓN ALCALDE RODRÍGUEZ, Street: 4F. This communication should reflect the following information: Name and surnames of the user, the request, the address and the supporting data. The exercise of rights must be performed by the user. However, they may be executed by a person authorized as legal representative of the user. In such case, the documentation proving this representation of the interested party must be provided.
